

Memorandum of Understanding (MoU)/LINKAGE

Between

Padmabhushan Vasantrodada Patil Mahavidyalaya, KavatheMahankal, Sangli

&

Miraj Mahavidyalaya, Miraj, Sangli

This Memorandum of Understanding (MoU)/ Linkage is effective as of 2023 to establish an affiliation by and between the following two institutes for the purpose of exchange of faculty, staff and students.

The MoU/ Linkage has been carried out between following two institutes:

1) Department of Physics, Padmabhushan Vasantrodada Patil Mahavidyalaya, KavatheMahankal. Tal.-Kavathe Mahankal, Dist.- Sangli.

2) Miraj Mahavidyalaya, Miraj affiliated to Shivaji University, Kolhapur

Parties wish to co-operate to explore the potential to work together in the following areas:

1. Sharing of infrastructural facilities.
2. Sharing academic facilities to conduct study visits and academic expertise guest lectures.
3. Sharing expertise, faculty exchange and student exchange.
4. Organizing seminars/ workshops/conferences in collaboration.
5. Organization Industrial visits for faculty, employees, students and their parents.
6. Collaborative research activities.
7. Organize hands on training programs for faculty and students.
8. Organization of Science awareness programs for society on various days like National Science Day, Celebration of Birth anniversary of renowned scientist like Dr. A P J Kalam, Dr Sarabhai etc.
9. Internship for students.
10. Organize Sky observation Programmes

COORDINATION

Each institution shall appoint one member of its teaching/training faculty to coordinate the program on its behalf. Further, a coordination committee consisting of a program coordinator from the side of all institutes will periodically review and identify ways to strengthen cooperation between both the institutions.

CONFIDENTIAL INFORMATION

Both institutes do not absolve any confidential information during the teaching/training/exchange/collaborative/cooperative activity.

VALIDITY

The Memorandum shall remain in force for FIVE years commencing from the effective date. Institutions may extend the term by written agreement signed by both after review.

TERMINATION

Either institution may terminate the MoU by giving written notice six months in advance to the other institution. Once terminated, none of the institutes will be responsible for any losses, financial or otherwise, which the other institutions may suffer. However, all will ensure that the provisions of this Memorandum shall continue to apply to all activities in progress until their completion.

AMENDMENT

This MoU may be amended or modified by a written agreement signed by the representatives of all institutes.

ADHERENCE TO LAWS

Participating faculties, staff and students involved in any activities under this memorandum must adhere to the law, rules and regulations of the institutions.

LEGAL EFFECT


Nothing in this Memorandum shall be construed as creating any legal relationship between the institutes. This Memorandum is a statement of intent to foster genuine and mutually beneficial academic development collaboration.


DISPUTE RESOLUTION


In case, there is a dispute relating to any aspect of academic cooperation, principals of both the institutes will jointly resolve the dispute in a spirit of independence, mutual respect, and shared responsibility.


Both the institutes welcome the establishment of this Memorandum for cooperation and jointly agree to the provisions as set out above.

The duration of this Memorandum of Understanding shall be seven years from the date of execution. It may be terminated before that time has expired by either Party giving not less than one month's notice in writing to the other. It may also be extended, if it has not been terminated prior to expiry of the five years, if both Parties so agree.
