Memorandum of Understanding

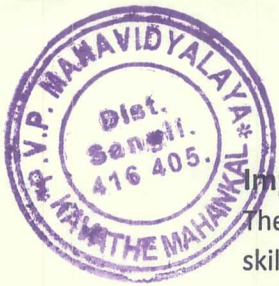
Scope of Cooperation

- D) The college will ensure all infrastructural arrangements, management person to arrange the program, projectors, Mic system etc for conducting these skill development programs.

- F) The Nilaya Education Group, Pune will be responsible to provide the resource persons and study materials for the same.
- G) The college will be responsible for making stay, food, snacks arrangements of the resource persons and the accompanying staff of Nilaya education Group, Pune.

Implementation and Funding

The Nilaya Education Group, Pune will not charge anything to the college for conducting these skill development programs; even if they charge fees to the students of the college directly they will try to keep the amount of fees minimal just to ensure recovery of the course material cost.

Purposes of this MOU:

Dispute Settlement

The Sides will consult together upon request of either side regarding any matter relating to the terms of this MOU and will endeavour jointly in a spirit of cooperation and mutual trust to resolve any difficulties or misunderstandings which may arise.

Amendment

This MOU may be amended by mutual written consent of the Sides.

Entry into Effect and Termination

1. This MOU will come into effect on the date of signature.
2. This MOU will remain in effect for an initial period of three (3) years and will be extended for successive periods of one (1) year, unless either side notifies the other side, in writing, of its intention to terminate this MOU at least three (3) months before the expiry date of the relevant period.
