This Memorandum of Understanding (the 'MOU') is made and entered into this on 15th day of November -2021 at KavatheMahankal sangli.

BY AND BETWEEN

Department Of Physical Education and Sports, Padmabhushan Vasantrodada Patil Mahaidyalaya, Kavathe Mahankal, Sangli which is a unit of the Shikshan Prasarak Sanstha hereafter known as First Party.

AND

KavatheMahankal Taluka Handball Association Kavathe Mahankal, Sangli, having its office at Vidyanagar Kavathe Mahankal which is a unit of the Sangli District Handball Association Sangli with the objective of Promotion of Handball, herein after known as Second Party.

Whereas KavatheMahankal Taluka Handball Association is implementing promotion of Handball in the Kavathe Mahankal Tehsil, Schools And Colleges.

Whereas both the parties share the common objectives and goals for promoting and developing Handball and individual sportspersons, therefore, both the parties agreed to work together on the following terms:

1. Department Of Physical Education and Sports, Padmabhushan Vasantrodada Patil Mahaidyalaya, Kavathe Mahankal will conduct tournaments for scouting talent and organize coaching camps for nurturing the talent in sports and games.
2. Department Of Physical Education and Sports shall be responsible for conducting tournaments in the existing sports infrastructure in College.
3. Any other activity on mutually agreed basis and whereas second party (KavatheMahankal Taluka Handball Association) which is having expertise in coaching and technical support shall provide necessary



technical support and guidance wherever necessary subject to availability of experts in different sports specific disciplines, and further, depending upon availability and allow access and usage of Handball Association for Handball sports related activity to Department Of Physical Education and Sports provided it does not dislocate or inconvenience implementation of Association 's own schemes.

4. The MOU will be on voluntary basis and either party can withdraw from it without any obligation if it so desires by giving a notice of 1 month.
5. This MOU is initially for a period of 5 years and may be renewed by mutual consent on same or revised terms as may be settled between the two parties.
