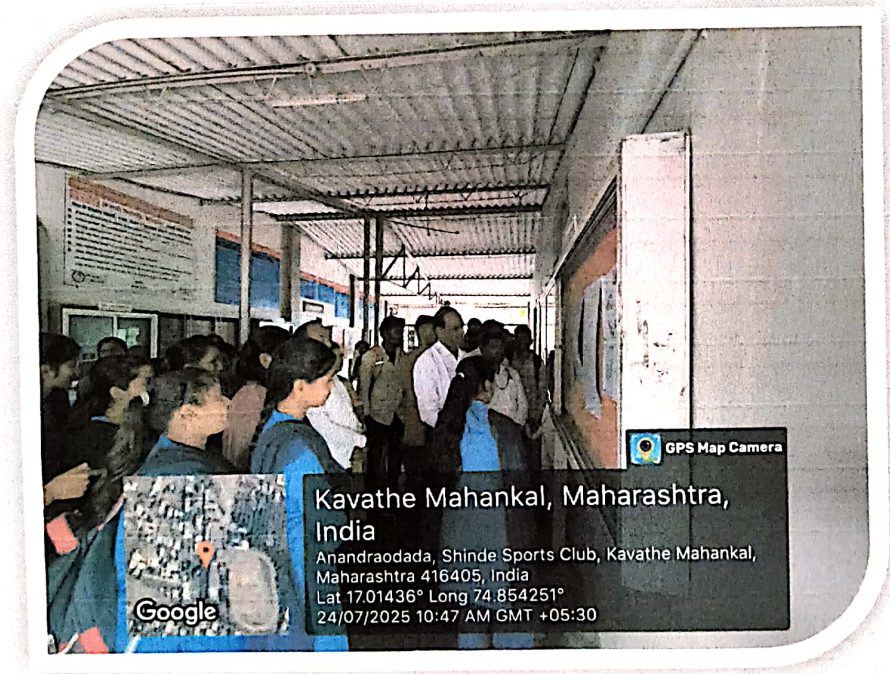

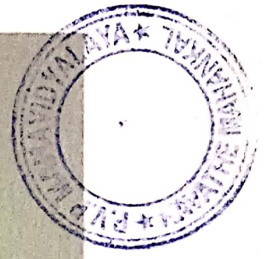

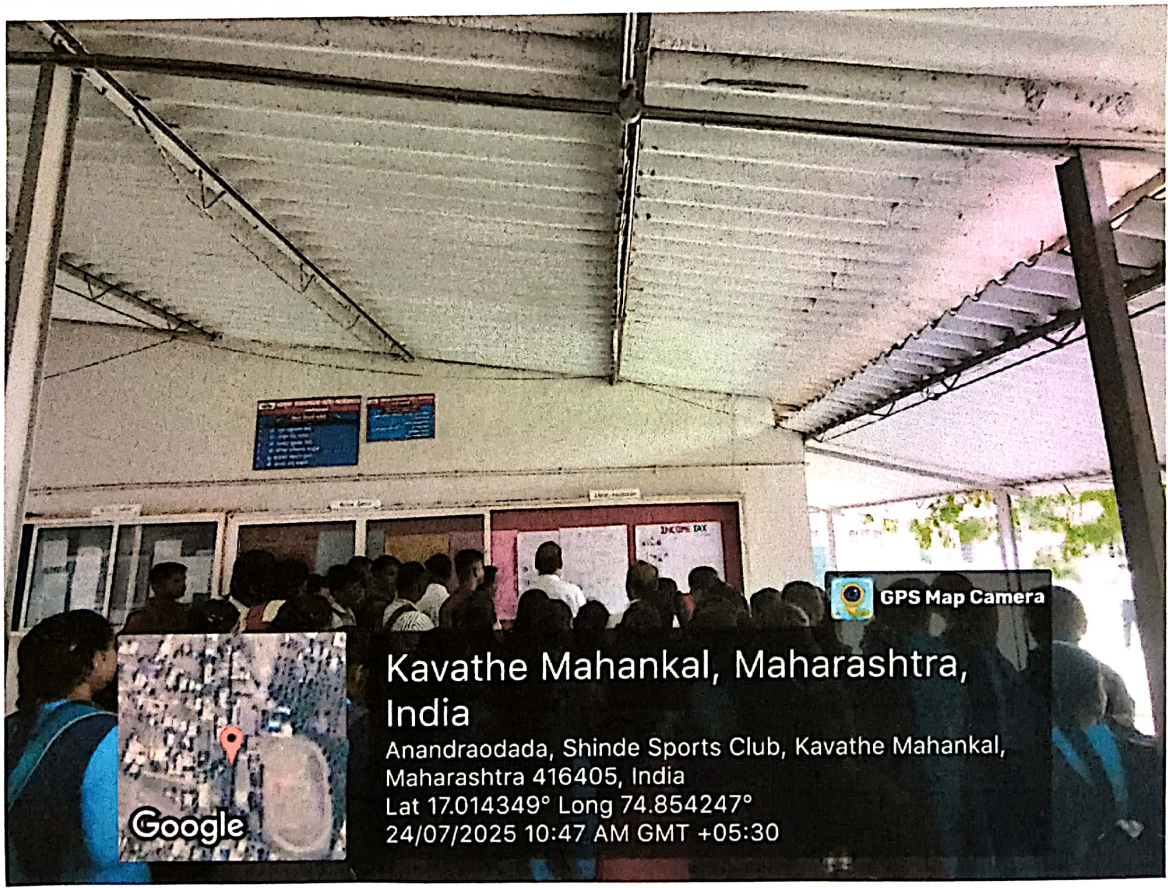


GPS Map Camera
