Appointment Letter

With reference to the discussion we had with you, we have the pleasure in informing you that you have been appointed as AUTOCAD DESIGNER. This appointment is with effect from 10<sup>TH</sup> JULY, 2023.

The terms and conditions of your appointment are as follows:

01. You will be on probation for a period of 6 (Six) months from the date of your joining the Company. If for any reason your performance is found to be unsatisfactory, the Company reserves the right to extend the said probation period for next 3 (Three) months and can extend for another 3 (Three) months, during which your service can be terminated without any notice or pay in lieu thereof.
02. You will be operating from Mumbai office.
03. Your total monthly gross emoluments, consisting basic, perks and indirect benefits is Rs.16,000 ( Sixteen Thousand Only), which shall be suitably broken up if so necessary. The above emoluments are subject to deduction of Income Tax and other taxes as applicable.
04. You will be eligible for 21 (Twenty one) days annual leave for each completed year of service which will not be carried forward and nor will it be cashable.
05. The Company may terminate your service by giving one month notice in writing or in lieu of notice, pay salary for the said period, provided, however, that no notice or salary in lieu of notice will be given in case your services are terminated for any misconduct done by you against the company or the management or any of the other employees. Similarly if your work is found to be detrimental to the interests of the Company or is found to be poor then the Company can terminate your appointment without notice or pay for that month.
06. You will be required to give one-month notice in writing if you wish to resign from the Company. However, it shall be open to the Company to accept your resignation from an earlier date in which event, you shall be entitled for salary only till your last working date in the Company.
07. Further, on giving the requisite notice of one month and also requesting for an early release from the company, then in the event of such request being acceded by the Company, you are, however, liable to pay the amount in lieu of salary for the notice period of one month. This Clause is applicable only for Confirmed employees.

08. On your decision to leave the Company, you will return to the Company any and all of the property of the Company in your possession including correspondence. You will also hand over all the papers and other pending works responsibly to the designated person by the Company.
09. If any misconduct is alleged against you, you can be suspended from duty without wages. However, if you are held guilty of all or any of the charges levelled against you, you will be treated absent from duty during the period of suspension.
10. In case you leave your job without giving proper notice and serving the notice period with the company, then company will have a right not to pay the earlier month's salary.
11. Your appointment shall be governed by the rules and regulations of the Company.
12. You shall carry out all lawful directions given by the Company and shall carry out all the duties of your employment honestly and with all diligence and shall promote the interests of the Company to the best of your skill and ability.
13. You shall devote whole of your time and attention to the business of the Company and shall not without the written consent of the Company be engaged or be interested whether directly or indirectly, in any other business or occupation of any kind whatsoever.  
If it is found that you are working in any other area and running a side business then this will be treated as a misconduct and will lead to immediate termination.
14. You shall not during the terms of your employment with the Company or at any time thereafter use, disclose to any other Company, firm or persons any of the secrets, business or affairs of the Company, nor shall you, without the previous consent of the Company at any time, during the currency of this employment, publication whether for remuneration or otherwise, relating to the affairs or business of the Company or to your work in the Company.
15. The remuneration and other terms of your engagement shall not be disclosed to other members of the staff of this Company and to any persons with the exception of close relatives.
16. A deduction of 10% of your gross salary will be made by the company from the 1st 2 months salaries and will be retained by the company. This retained amount will be due to the employee only after he completes 6 months of working with the company and will be released with the full and final amount when the employee leaves the company beyond 6 months of working. In case the employee leaves the company on his own accord before completing 6 months then this retained amount will be forfeited. In case the Company asks the employee to resign before the 6-month period then this retained amount will be released with the full and final settlement.
17. You may be required to serve in the offices of the Company in the Indian Union and in any other department. In case of your transfer to any establishment of the Company, the service conditions applicable to that establishment will be applicable to you.



You are required to communicate to the Company your latest mailing address from time to time, failing which the last known address on the Company's record will be taken as the current address for all communications to you

19. The age of retirement will be 60 years subject to the provision of law. (Birth certificate issued by a competent authority should be produced before joining the duty).

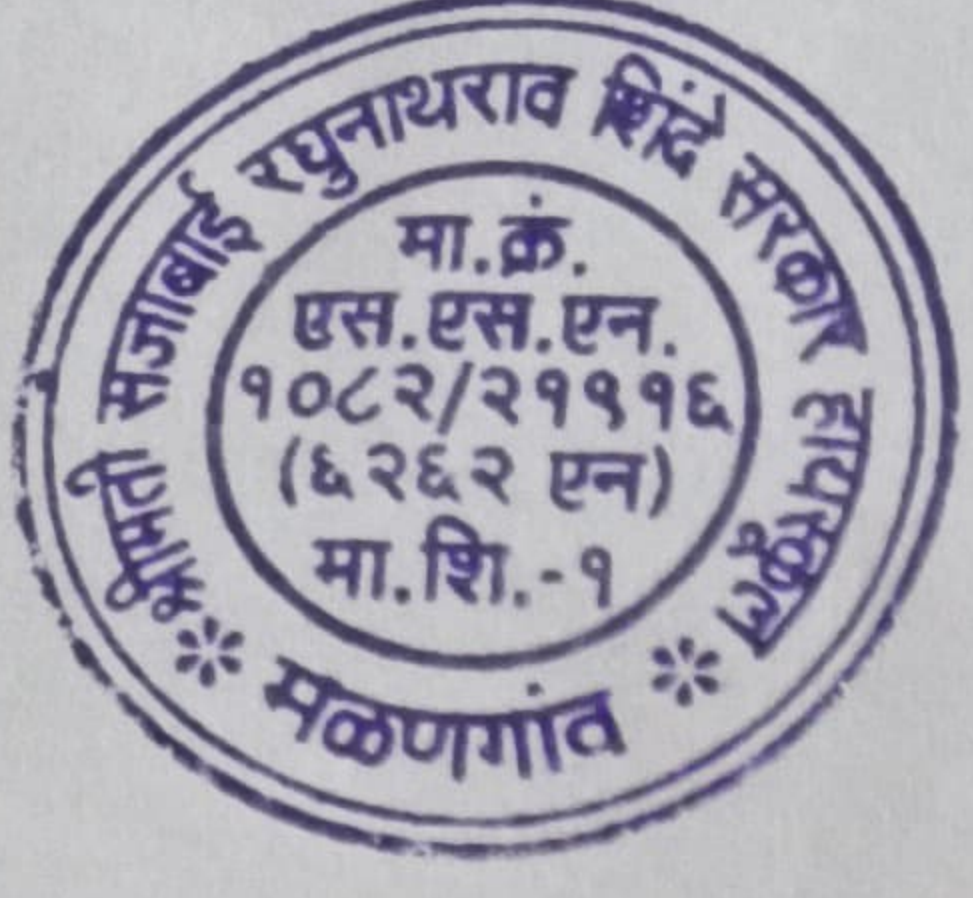

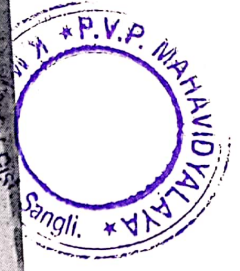

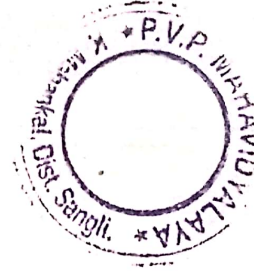
